2.1 Brief summary of the proceedings and the details of items deliberated

The Chairman further informed that in compliance with the provisions of the Companies Act, 2013 and the SEBI Listing Regulations, the Company has provided remote e-voting facility to its Members, to transact the business set out in the Notice of 109th AGM. 1. Adoption of Standalone and Consolidated Annual Audited Financial Statements for the year ended 31st March, 2022 including the Balance Sheet as at 31st March, 2022 and Statement of Profit and Loss for the year ended on that date and the Reports of Board of Directors and Auditors thereon.
2. Declaration of Dividend on Equity Shares of the Company for the financial year ended March 31, 2022.
3. Re-appointment of Mr. Shreeyash Bangur (DIN 00012825), as a Director of the Company, liable to retire by rotation.
