However, please note that this does not mean that the Member companies do not have any direct holdings.

Considering the limitations of the XBRL format of Table V, we have only provided the direct holdings of SBOs and declared that the SBOs exercises control over The Peria Karamalai Tea & Produce Co Ltd.

Further, the holding of Lakshmi Niwas Bangur (HUF) in the Company has been included in the direct holding of Mr. Lakshmi Niwas Bangur, being the karta of the HUF.
