Dear Sir,

We are pleased to inform you that the shareholders of the Company by passing special resolution through Postal Ballot on 13th December, 2024 have approved your appointment as an Independent Director of the Company for the consecutive period of 5 years w.e.f 20th September, 2024, as envisaged under section 149 read with Schedule IV and other applicable provisions of the Companies Act, 2013 and SEBI (LODR) Regulations, 2015.

The terms and conditions of your appointment are as follows:

1. Term of Appointment

Your appointment as an Independent Director is for a period of five years commencing from 20th September, 2024, during which period you will not be subject to retirement by rotation. Your tenure will also be subject to your continuing to meet the criteria of Independence.

Your appointment will also terminate automatically on the expiry of the terms of appointment as above, or if you vacate your office in terms of Section 167 of the Act. There is no compensation for termination of office in any circumstances.

2. The expectation of the Board from the Independent Director

- Time Commitment:** The Company anticipates a commitment of sufficient time and attention as necessary in order to perform your duties under the appointment.
- Strategy:** The Company expects that you will constructively contribute to the development of strategy.
- Performance:** You shall scrutinize the performance of management in meeting agreed goals and objectives and monitor the reporting of performance.
- Risk:** You should satisfy yourself that the financial information is accurate and that financial controls and systems of risk management are robust and defensible.
- Confidentiality:** You must apply the highest standards of confidentiality and not disclose to any person or Company (whether during the course of the Appointment or at any time after its termination) any confidential information concerning the Company and any group Companies with which you come into contact by virtue of your position as a Non-Executive Independent Director of the Company.

- d) You shall display utmost alacrity in approving financial statement.
- e) You shall disclose interest in any of the contract or arrangements proposed to be entered by the Company and you should disclose the interest on periodical basis as required under law.
- f) You shall strive to attend all meeting including Board, Committee and General Meetings. You shall actively participate in the meetings.
- g) You shall not compromise or allow to compromise "Independence"
- h) You shall not misuse the assets, property, information or any other matter that may be in possession, in the capacity as a Director of the Company.
- i) You shall not engage in Insider Trading activities.
- j) You shall ensure compliance of all the laws of the land.

The above list is only indicative and not exhaustive.

5. The Code of Business Ethics that the Company expects its directors and employees to follow:

The Company has formulated a detailed Code of Conduct for the Board of Directors and Senior employees of the company. The code of conduct is also displayed in the Company's website. You shall annually affirm, in writing, the compliance with the code.

- v. enter into any contract or arrangements wherein you directly or indirectly interested.
