The Board of Directors of the Company at its meeting held on Tuesday, the 3<sup>rd</sup> day of February, 2026, approved the conduct of a Postal Ballot pursuant to the provisions of Section 110 read with Section 108 of the Companies Act, 2013 ("Act") and Rules 20 & 22 of the Companies (Management & Administration) Rules, 2014 (including any statutory modification or re-enactment thereof for the time being in force) ("the Rules"), read with the General Circular No. 14/2020 dated 8th April, 2020, General Circular No. 17/2020 dated 13th April, 2020, and subsequent circulars issued in this regard, the latest being General Circular No. 03/2025 dated 22nd September 2025 ("General Circulars") issued by the Ministry of Corporate Affairs ("MCA"), as amended from time to time and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("the SEBI Listing Regulations"), as amended from time to time and the Secretarial Standards on General Meetings issued by The Institute of Company Secretaries of India ("SS-2") to seeks consent of its Members for the Special Business as mentioned below, proposed to be passed as an Ordinary Resolution by way of Postal Ballot through remote e-voting process ("Postal Ballot"/"E-voting").

### 1. ORDINARY RESOLUTION: APPROVAL FOR MATERIAL RELATED PARTY TRANSACTIONS

The Board of Directors had appointed M/s Vinod Kothari & Company, Practicing Company Secretary, as Scrutinizer for conducting the postal ballot (e-voting process) in a fair and transparent manner.

1. I, Barsha Dikshit, Partner at Vinod Kothari & Company, Practising Company Secretaries, (Membership No ACS A48152/ C.P. 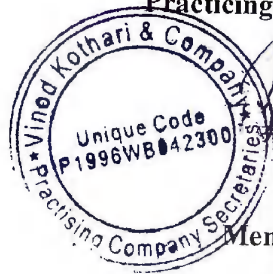
